Member savings on office visits

Inpatient deductible

Facility outpatient surgery deductible

In addition to annual deductible -- \$200 per occurrence, regardless of annual deductible choice

Emergency Room deductible

In addition to annual deductible -- \$100 per occurrence, regardless of annual deductible choice
