Top Five Reasons to Get Your NPI Now

You may have been asking yourself "Why should I obtain an NPI"? Here are the top five reasons to get your NPI now:

5. – Don't Wait

As the implementation date nears, more and more providers will be requesting NPI. Wait times will likely increase. If you do not have your NPI by May 23, 2007, you will not be able to conduct HIPAA-standard electronic claim transactions.

4. – NPI is Complex

NPI requires significant changes for you, your vendors, Centers for Medicare and Medicaid Services (CMS), and the health plans with which you contract. Getting your NPI now will allow you time to make system and process changes, both internally and with your billing services / clearinghouses.

3. – Testing Opportunities

The sooner you get your NPI, the sooner you can start testing your systems, your vendors' systems and our systems.

2. – Administrative Ease

Your NPI will replace UPIN, Medicaid and Medicare provider numbers, Blue Cross Blue Shield plan numbers and other health plans' internal proprietary provider numbers. Now, you will have fewer numbers to remember when submitting claims and conducting business with BCBSOK.

If you have not notified us of your NPI by March 15, 2007, your payments may be affected!

**You need to notify us of your National Provider Identifier by March 15, 2007 to minimize any potential impact on payments!

- Accepts the revised CMS-1500 (08/05) paper claim form (see article below).
- Allows you to use both your NPI and your BCBSOK provider numbers on all standard electronic transactions and the revised CMS-1500 (08/05) paper claim form.
- Offers ongoing training, including "NPI 101" and "NPI 201" courses with detailed NPI information posted at www.bcbsok.com.

- Provides updated online companion guides for transaction testing at: www.thinedi.com/hipaa/comp_docs.htm.
- Offers updated NPI information on our Web site at: www.bcbsok.com.

In the future, you can expect even more from BCBSOK, such as:

- Acceptance of the new UB-04 paper claim form.
- Continued requests for your NPI if you have not already submitted it to us.
- An NPI 301 training course for even more detailed information on NPI and BCBSOK.
- Updates to the NPI section of our Web site at www.bcbsok.com.

BCBSOK Now Accepting Revised CMS-1500 Forms

As part of the transition to using NPI, providers may now submit claims to BCBSOK using the newly released revised version of the CMS-1500 Health Insurance Claim Form (version 08/05). This updated form is specifically designed to accommodate the reporting of NPI and is available on the National Uniform

Claim Committee Web site at: www.nucc.org/content/view/12/35/.

We will continue accepting the current form in addition to the revised form until April 1, 2007. However, after April 1, 2007, only the revised CMS-1500 Health Insurance Claim Form (version 08/05) will be accepted.

Critical Dates and Milestones to Remember

Collection Phase – July 2006 BCBSOK started initial data collection, requesting that all providers submit their NPIs to us.

Transition Phase - Ongoing BCBSOK will accept NPI numbers along with your existing BCBSOK ID on standard electronic claim transactions.

Providers may submit claims using the current or revised CMS-1500 Health Insurance Claim Form. After April 1, 2007, providers must submit claims using ONLY the revised version of the CMS-1500 Health Insurance Claim Form (version 08/05).

CAUTION!

If you don't obtain an NPI, your payments may be affected. You will not be able to use standard HIPAA electronic transactions with the CMS or other health plans. In addition, per federal regulations, penalties may be assessed for non-compliance. We recommend you apply for your NPI well in advance of the deadline to ensure you avoid any penalty.

How to Obtain your NPI(s)

To receive your NPI(s), submit an application online at: www.nppes.cms.hhs.gov or contact the NPI Enumerator at 1-800-465-3203 to request a paper application.

Once you receive your NPI, notify BCBSOK by completing the NPI Submission Form or submitting your NPI directly online at www.bcbsok.com. Go to the Health Care Providers section, click on the NPI logo and select the link entitled "Submit your NPI to us here" to find copies of the form and/or submission instructions.

You will also want to distribute your NPI(s) to other entities with whom you transact business electronically. Programming changes, systems integration and testing with other vendors may be required to ensure everything is working correctly.
