

Tips for Using AIM Specialty Health[®]



AIM Specialty Health's prior authorization services improve provider efficiency for pre-service and post-service reviews Applies to some Blue Cross and Blue Shield of Oklahoma (BCBSOK) commercial members

The AIM *ProviderPortal*SM will simplify pre- and post-service reviews

- Use the AIM <u>*ProviderPortal*</u> to request prior authorization (pre-service)
- Post-service review requests should also be submitted directly to AIM via the *ProviderPortal*
- Do not submit medical records to BCBSOK for care categories managed by AIM
- If medical records are needed, AIM will request them via the *Provider*Portal

Care categories that require prior authorization through AIM effective Jan. 1, 2021

- Advanced imaging and cardiology
- Joint and spine surgery, pain management

- Genetic testing
- Radiation therapy

Benefits will vary based on the service being rendered and individual and group policy elections. Always check eligibility and benefits first, through Availity[®] or your preferred web vendor. This step will confirm coverage and other important details, such as prior authorization requirements and vendors.
