If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.
Are there services covered before you meet your deductible?	Yes. Services from Indian health care provider, In-network preventive health, services with a copayment, and certain prescription drugs are covered before you meet your deductible. Does this plan provide Minimum Essential Coverage? Yes.

If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.
