<b>What is the overall <u>deductible</u>?</b>	\$0 at Indian Health Care <u>Provider</u> (IHCP) or with IHCP <u>referral</u> at non-IHCP; or <u>Network</u> : \$1,200 Individual/\$3,600 Family Out-of-Network: \$3,600 Individual/\$10,800 Family	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
<b>Are there services covered before you meet your <u>deductible</u>?</b>	Yes. Services from Indian Health Care <u>Providers</u> and In-Network Preventive Health, certain services with a <u>copayment</u> and some <u>prescription drugs</u> are covered before you meet your <u>deductible</u> . - Long-term care
- Non-emergency care when traveling outside the U.S.
- Routine eye care (Adult)
- Routine foot care (due to systemic disease and in connection with diabetes)
- Weight loss programs

### Does this plan provide Minimum Essential Coverage? Yes

If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.
