If you have other family members on the plan, each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
<b>Are there services covered before you meet your deductible?</b>	Yes. Services from Indian health care <u>provider</u> and In-network preventive health, services with a <u>copayment</u> and some <u>prescription drugs</u> are covered before you meet your deductible. ### Does this plan provide Minimum Essential Coverage? Yes
